## PRE-ADMISSION COURSE REQUIREMENTS FOR ANY NURSING A.A.S. PROGRAM

The Associate of Applied Science degree program in Nursing Technology a selection-based program, meaning a student must APPLY to the program and then be SELECTED into the program before being able to meet graduation requirements. The following COTC courses (or their equivalents) must be completed prior to being admitted into the NUR.AAS program. All courses must be completed with a grade of C (2.00) or better.

- 3. CMP-1601 Principles of Computing (1 credit hr)
- 2. MTH-1215 College Algebra (5 credit
- 4. (CHM-1700 Basic Chemistry and CHM-1710 General Chemistry) or (CHM-1713 Chemistry Fundamentals)

## PRE-ADMISSION COURSE REQUIREMENTS FOR NURLP.AAS program

The following courses must be completed with a grade of C (2.00) or better prior to admission into the NURLP.AAS program at COTC.

- 1. BHS-1030 Reasoning Skills (4 credit hrs)
- 3. BIO-1772 Human Anatomy & Physiology I (6 credit hrs)
- 2. BHS-1376 General Psychology (5 credit hrs)
- 4. BIO-1773 Human Anatomy & Physiology II (6 credit hrs)

All Applicants to the L.P.N. to A.D.N. Plan of Study must first successfully meet admission criteria set forth by COTC.

Prerequisites for COTC courses are the responsibility of the student (See the COTC Web Page). A grade of C (2.00) or better is required for all courses listed on this Plan of Study in order to continue in and graduate from the Nursing Technology program.

Credit will be earned for the following courses: BHS-1345 Human Development, NUR-4233 Nursing I, NUR-4234 Nursing II, NUR-4236 Nursing IV AFTER a grade of C (2.00) or better has been earned in NUR-4237 Nursing V.

The combined GPA for that quarter must be 2.00 or better.

All applicants must hold current unencumbered Ohio PN Licensure with medication endorsement in the State of Ohio.

L.P.N. to A.D.N. Transition course must be taken prior to NUR-4237 Nursing V. Credit for NUR-4240 L.P.N. to

A.D.N. Transition course counts neither for elective credit nor toward meeting the minimum credit hours for graduation.

Prerequisites for admission to the A.D.N. program must be met prior to admission to the L.P.N. to A.D.N. program. All non-Nursing technology courses must be successfully completed prior to admission into the L.P.N. to A.D.N. Plan of Study

All Nursing courses must be followed in sequence according to this Plan of Study.
